

## **CFA Program Student Scholarship Overview**

As a participant in the University Affiliation Program (UAP), your university is allotted scholarships that you can award to any student enrolled at your university based on the **scholarship allotment criteria**. All scholarship awards must be made by 31 July 2024 and any not awarded will be forfeited and cannot be carried forward to the 2025 program year. If you require additional documentation as part of a complete application package, please complete the **Additional Requirements Form**. Your submission will be recorded and updated to the **Additional Requirements Before Submission** document.

CFA Program Student Scholarships waive the one-time program enrollment fee and reduce the exam registration fee to USD400 plus any applicable local taxes. Recipients can use their scholarship for any exam that is open and available for registration within one year from the date of award.

Students that are not selected for award will receive the early registration pricing for up to one-year from the date of your decision. Note that a decision of 'Not Selected for Award' must be made for the student to receive the early registration pricing. For more refer to the FAQ section.

When you submit a review decision of either 'Selected for Award' or 'Not Selected for Award' an email is sent immediately to the student informing them of your decision. It is important to remember that your decisions are final as scholarships are non-transferrable.

#### Eligibility

To apply for a CFA Program Student Scholarship the applicant must:

- Not be currently registered for a CFA Program exam.
- Be enrolled at an affiliated university. Note applicants are not required to be enrolled in an affiliated degree program to be eligible to apply for or receive a Student Scholarship.

## **The Scholarship Platform**

An online account at http://www.cfainstitute.org is required to access the online scholarship platform. If you do not have an existing CFA Institute account, please create an account using this guide and then email your CFA Institute ID number to university@cfainstitute.org and access will be granted within 24-48 hours.

The scholarship platform is available at your convenience to review submissions and make review decisions at <a href="http://www.cfai.smapply.io">http://www.cfai.smapply.io</a>.

You must log in using your CFA Institute username and password. 
#### How to Review Scholarship Submissions

Access to the platform is available using your CFA Institute login credentials (email and password).

1. Visit http://www.cfai.smapply.io and click 'Log-in' at the top-right of the screen. Note that the preferred browser for this site is Google Chrome.

- The application review process appears in a split screen. The left side displays the application currently under review. The right side is where you submit your review decision ('Selected for Award' or 'Not Selected for Award').
  - **Selected for Award** This decision will award a CFA Program Scholarship to the applicant. This decision will reduce your remaining allocation by one.
  - Not Selected for Award This decision will NOT award a CFA Program Scholarship to the applicant. This decision will not reduce your remaining allocation.

6. Click the green 'Mark as Complete' button to submit your review decision. You will be asked a second time to confirm your decision. Remember, your decision is immediate and final.

The screen will be idle for a few moments and will eventually refresh and if you made a 'Selected for Award' decision your remaining allotment will be reduced by a value of 1. With either selection the student is notified within moments of your decision of the outcome of their application. You will also receive a copy of their award notification email. Please retain for your records as applications that have been reviewed will no longer appear on your dashboard.

7. Navigate to the next or previous application using the '>' or '<' buttons in the upper right-hand side of the screen.

#### What if I am having trouble logging in to the platform?

Please make sure you are using Google Chrome browser to access the platform. You may need to use an 'Incognito' window to access the platform (http://www.cfai.smapply.io) If using an incognito window in Google Chrome does not resolve the issue, please call our Global Contact Center for further assistance.

#### How many scholarships do I have remaining to award?

Log in at http://www.cfai.smapply.io and click on your name at the top-right of the page. Then scroll down to the 'Extra Info' section and you can see your total program year allotment and your remaining allotment.

#### Am I obligated to review all applications submitted to my university?

As the Principal Contact at your university, it is your responsibility to review submissions and make award decisions. We do encourage you to do so early and often to allow those not selected to register and begin their studies.


#### What are the deadlines to submit award decisions?

Your program year allotment must be awarded by 31 July each year. Unused scholarship allocations cannot be carried forward to the next program year. It is important to note that scholarship awards are not bound to specific exam offerings and as a result there are no deadlines throughout the program year other than previously mentioned 31 July date. Awards are redeemable for any exam that is open and accepting registrations within one-year from the date of award.

I have a student that would like to sit for a specific exam offering. When should I make the award decision by? There are no deadlines for submitting your decisions and exam registration deadlines are subject to change due to capacity and/or availability concerns. We cannot guarantee scholarship recipients will be able to register for their preferred exam offering.

#### How will I know when an application has been submitted?

Once an application is submitted you will be notified via email. A sample of the email is below.



#### Can students edit their applications after they are submitted? If so, how?

If a student has submitted their application they can email **scholarships@cfainstitute.org** and request that their application be 'reopened' to allow them to make edits and resubmit. They should only request a withdrawal of their scholarship if they no longer want to be considered for a CFA Program Student Scholarship.

#### How will students be notified if they are selected or not selected for award?

When a decision is made on an application the student is notified immediately and the decision is final. You will also receive the exact same email for each award decision made. We encourage you to keep these emails to track your award decision history.

When a 'Selected for Award' decision is made the student receives a message like the one below.



Congratulations! You have been awarded a CFA<sup>®</sup> Program Student Scholarship. The Student Scholarship waives the one-time enrollment fee and discounts the exam registration fee to USD400.

Please allow seven to ten business days from the date of this email before registering for an exam. This will ensure the scholarship discount is reflected in your account. We urge you to choose the exam offering that best accommodates your study routine and register early to ensure adequate time to prepare for the exam.

Please note that your award will expire **one year from the date of this email.** Click **here** to register/enroll for the exam of your choice, prior to this expiration date. It is your responsibility to be aware of and abide by the **important exam dates**.

**Important registration note:** The full exam pricing will display on your initial exam registration page. You will see the final, discounted pricing reflected in the payment section during the checkout process. Please be certain of the **payment method** you wish to use before you reach the checkout. If you exit the registration process or change your payment method, the discounted rate will revert to the full fee.



#### Can students that have already completed their exam registration apply for a scholarship?

No, registered candidates are not eligible to apply for or receive a scholarship. They can only apply if they have not yet registered. Once a registered candidate receives their exam results, they are welcome to apply for a scholarship for a subsequent exam. If a student that is registered attempts to submit a CFA Program scholarship, they will receive the below message.



#### Can a registered student be awarded a scholarship and receive a refund of the difference?

No, registered candidates are not eligible to apply for or receive a scholarship. If a student is not registered and submits a CFA Program Student scholarship but later registers before receiving the award decision email, their application will be voided. They will receive an email confirmation if this occurs. A sample of the email is below.

\* Full-time is defined as teaching no fewer than six (6) credit hours per quarter or semester (or equivalent) or an administrator teaching a minimum of three (3) credit hours per quarter or semester (or equivalent).

\*\* Part-time is defined as teaching no fewer than three (3) credit hours per quarter or semester (or equivalent) at one college or university.
