## **BCAP 20th Anniversary**

This summer, we celebrated the 20th anniversary of the Business Careers Awareness Program (BCAP). BCAP is a partnership initiative between EY and the DRSOA that gives opportunities to high school students who are typically underrepresented in undergraduate accounting and business majors. In this program, students learn the fundamentals of business and are exposed to business careers, the University of Arizona and the Eller community. BCAP exists because of the creativity, insight and persistence of two individuals - Ron Butler '91 BSBA (Accounting), and retired professor Leslie Eldenburg. Ron graduated from our accounting program in 1991 and has remained engaged and committed to the University since then despite his increasing professional

responsibilities. When Ron was still a manager with EY, he advocated for funding from the EY Foundation to launch the BCAP program. His passion for exposing students to accounting career possibilities has translated into bringing more than 700 students through the program in the last 20 years. In the spirit of celebrating 20 years, Ron made an announcement at the event, committing to adding \$20,000 to the Eldenburg Endowment. This endowment funds one scholarship, given out every year at the end of the BCAP program to a student who embodies the commitment to community and kindness of Leslie Eldenburg. #### **Professional Development Programming**

Our School continues to focus on the professional development of our students, ensuring their success in the workplace following graduation. This academic school year, the School of Accountancy held the following professional events in both Fall and Spring semesters:

#### **Meet the Firms**

Each semester, the DRSOA hosts Meet the Firms in McClelland Hall. We are proud of our commitment to connecting students with potential employers and setting them up for success through resume workshops. The event includes over 40 recruiting companies and over 200 participating students.



#### **Tax Career Exposure Event**

This event was held for undergraduate accounting majors, including those newly admitted, to hear about different careers in tax. They worked through a virtual learning experience through PwC, working alongside other students with the help of MAcc-Tax students.

#### **PwC Connect**

PwC Connect is a program designed to expose highperforming, traditionally underrepresented minority first-year students to the professional services profession. PwC has provided funding for this program for the last eight years. This event provides selected participants with the opportunity to interact and learn from knowledgeable PwC professionals. The program includes a series of workshops and one-onone mentoring with a PwC professional. Approximately 30 students participated in the 2024 PwC Connect program.

#### **EY Diversity Dinner**

The EY Diversity Dinner is an opportunity designed to expose traditionally underrepresented minority students to the many ways that they can get involved with EY at all stages of their academic and professional journey. Students hear from EY professionals who share their personal experiences, career journeys, and what drives them to succeed. Almost 40 students participated in the event last Fall.



## **Deloitte Programs**

#### **First Generation Together Program Success**

We were pleased with another successful year of our First Generation Together program with the Deloitte Foundation. This program allows us to offer smaller class options for first-generation college students for the ACCT 200 Introduction to Financial Accounting course. This gives the students a more comfortable setting to ask questions and bond with their peers and faculty. In addition to improving their success in the course, the small sections also lead to an increased interest in the accounting major. The program includes a field trip to the University Campus Store for students to learn how it orders, receives, stores and accounts for their inventories.



#### **Deloitte MADE Leadership Summit**

For the third year, DRSOA was invited to attend the Deloitte MADE Leadership Summit at Deloitte University near Dallas, TX. Two faculty members accompanied nearly 30 students, who received valuable exposure to the accounting profession and career path options while seeing a diverse representation of professionals in the field.

#### **Deloitte Arizona Latino Student Mentorship Program**

The Arizona Latino Student Mentorship program is in its third year with student participation growing each year. This year 25 sophomores and juniors were admitted to the program. During the program, students develop professional networking and communication skills while exploring various career disciplines and functions. The program sessions also focused on career development and breaking through barriers as future Hispanic/LatinX business leaders. The program is led by Deloitte with various corporate partners, including APS, Bank of America, BMO Harris Bank, Gen Digital, and JP Morgan. We appreciate the leadership of Deloitte professionals including Ken Udenze, Jose Bustillos, Maria Zunzunegui-Navarro, Christina Lange ('07 BSBA) and Richard Ortiz.



#### **Deloitte Audit Innovation Workshop**

Over 50 students attended the Deloitte Audit Innovation Workshop to learn more about the latest in audit and assurance technologies. Topics included leveraging AI, advancing ESG readiness, digitizing asset counts, automating valuations, and identifying data trends.



## **Deloitte Foundation Accounting Scholars Program**

In an effort to increase representation of racially and ethnically diverse students in accounting master's degrees, the Deloitte Foundation continues to partner with the U of A to cover 100 percent of tuition and fees for either the MAcc or MSA program. 



## Where do our Graduates go?

The graphs below show a breakdown of where students have gone to work after graduation. Between Fall 2023 and Spring 2024 graduates, the undergraduate placement rate (including continuing education in graduate school) was 96 percent, main campus master's placement rate was 100 percent, and online MSA and Graduate Certificate placement rate was 92 percent. These statistics capture all students with the legal right to work in the United States.





About 60 percent of graduates accepted jobs in Arizona. The next most popular destination for our graduates was California, with 10 percent.
