

**OMHM/OSMA Dual Degree
(Online Masters in Healthcare Management /
Online Master of Science in Accounting)**

The Dual OMHM/OSMA degree program is recommended for students wishing to pursue a career in healthcare management and/or accounting. The demand for healthcare management education has significantly increased in the past several years, and students who also master the concepts of accounting will be in high demand by employers. The Dual OMHM/OSMA degree will train students in the necessary healthcare management and accounting skills to advance their careers with potentially only one additional semester of coursework.

In general, the Dual OMHM/OSMA degree can be completed in as little as two years. If additional prerequisites for either program are required, the program may take an additional semester to complete.

The student must be admitted to both the OMHM and OSMA programs. University policy on dual degrees stipulates that a maximum of 50% of the credit hours for the shorter program may be counted toward both degrees. Therefore, the OMHM/OSMA degree requires a total of 45 units.

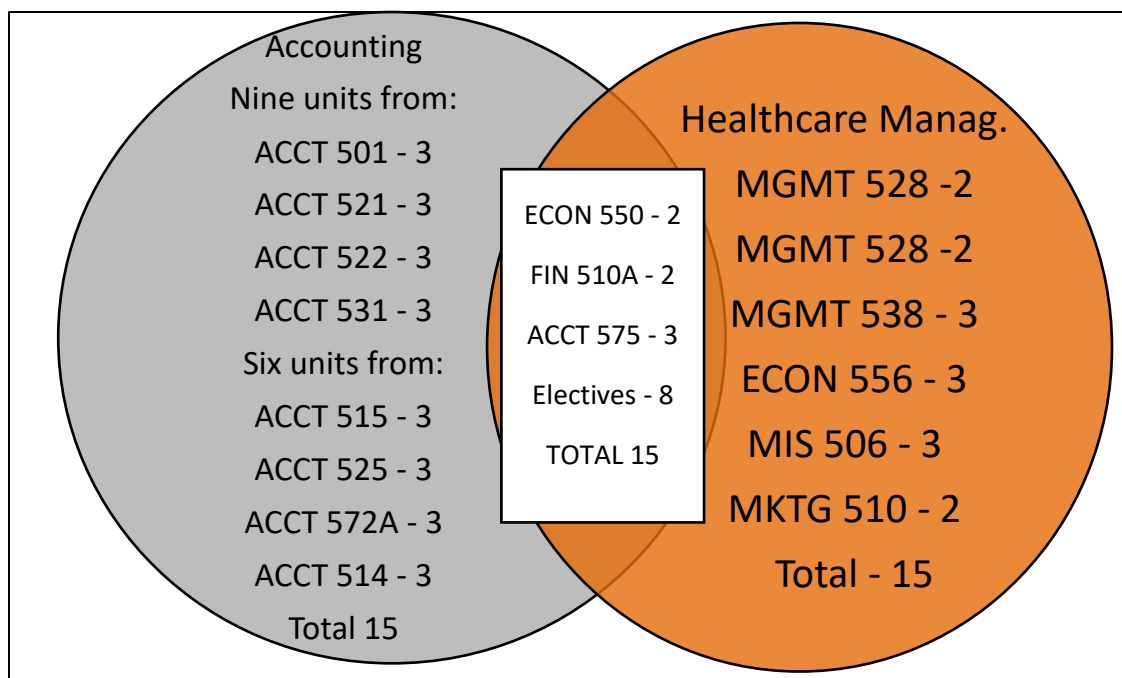
In summary:

The student must meet the prerequisite requirements for both degrees.

OSBA Degree requirements: 30 units of coursework

However, up to 15 units of course work may be counted toward both degrees, as described below. To receive the dual degree, the following are required:

OMSA Coursework

Prerequisites

The following are considered prerequisite courses for the OMSA program. Some of these courses can be completed during the program, but are not counted towards the units needed to complete the dual OMHM/OMSA degree. The dual degree program will be promoted to students with a business undergraduate degree, who will almost certainly have completed the introductory financial and managerial accounting prerequisite listed below (ACCT 200/210). The remaining prerequisites can all be completed in an initial summer start term.
