# OMSE/OMSA Dual Degree (Online Master of Science in Entrepreneurship / Online Master of Science in Accounting)

The Dual OMSE/OMSA degree program is recommended for students wishing to pursue a career in accounting focusing on entrepreneurial ventures, small business development, or corporate innovation. The dual degree program is particularly well suited for students that would like to obtain a broad range of innovation & entrepreneurial venture development knowledge along with a specialization in accounting.

In general, the Dual OMSE/OMSA degree can be completed in as little as two years. If additional prerequisites for either program are required, the program may take an additional semester or two to complete.

The student must be admitted to both the OMSE and OMSA programs. University policy on dual degrees stipulates that a maximum of 50% of the credit hours from the degree with fewer total units may be counted toward both degrees. Therefore, the duel OMSE/OMSA degree requires a total of 45 units.


### In summary:

The student must meet the prerequisite requirements for both degrees.

- OMSE Degree requirements: 30 units of coursework
- OMSA Degree requirements: 30 units of coursework

However, up to 15 units of course work may be counted toward both degrees, as described below.
