Welcome! I hope you enjoy this quick update regarding our students, faculty, and programs.

Finance is the number one major demanded by students entering Eller. The department taught over 100 class sections to undergraduate, MBA, MSF, and PhD students this year.

Demand for our outstanding graduates remains exceptionally strong: Leading companies hiring Eller finance students, among others, include BofA/Merrill Lynch, BDO, BlackRock, Bloomberg, Boston Consulting, Citi, Deutsche Bank, Dimensional Fund Advisors, Goldman Sachs, Intel, JP Morgan, Siemens, UBS, and Wells Fargo.

Nineteen Eller students are starting internships or full time positions at major Wall Street firms, including Goldman Sachs, BlackRock, UBS, Morgan Stanley, Citi, RBC, and Deutsche Bank.

We awarded more than \$91,000 in 57 scholarships to finance students. Thank you for your support! We also awarded five Chartered Financial Analyst and eight Chartered Alternative Investment Analyst exam scholarships. Jeff Welter, Associate Director for Professional Development, received the University of Arizona 2017 Award of Excellence for his work in building opportunities (especially on Wall Street) for our students!

## **Meet Our Students**

### Doctoral

Charles Favreau received his Ph.D. from the University of Arizona in May 2017. Prior to joining the doctoral program, he earned his M.S. in Finance from the University of South Florida. In Fall 2017, Charles will start as an assistant professor at Duquesne University in Pittsburgh. "As a hub for artificial intelligence and machine learning, Pittsburgh will provide exposure to innovative modeling tools designed to investigate outliers and non-normal distributions, which have become characteristic of financial markets."

Charles' research interests include investments and the determinants of household investment decisions. Under the guidance of Dr. Richard Sias, Charles' dissertation, "Do Peer Effects Influence Portfolio Choice? Evidence from 401(k) Allocations," investigates employees' investment in employer stock, which is an investment choice discouraged by finance professionals. Charles finds that employees invest more in company stock when their peers invest more – a finding that implies that policies involving education alone may fall short at preventing investors from making poor decisions.

During his time as a Ph.D. student, Charles took the opportunity to enroll in a variety of statistical modeling courses such as R programming, econometrics, and big data analytics. "The aspect that drew me to the UA was its reputation for research in investments. Eller provided everything I was looking for and more. In addition to the variety of modeling courses offered, the faculty at Arizona go out of their way to develop engaging curriculum and make themselves available to students. This level of dedication gives UA students an opportunity for a very rewarding education."

Bill Lomicka has been a longtime supporter of the Eller Finance Department. Bill earned his MBA from The Wharton Graduate School of the University of Pennsylvania.

Bill has nearly five decades of financial management experience with particular expertise in the area of rapidly expanding service companies. He worked with Humana as Senior Vice President-Finance, followed by a position with a healthcare venture capital firm in New York City. He acted as Secretary of Economic Development for the Commonwealth of Kentucky, and then later formed a Louisville-based private investment firm specializing in venture capital.

In 1999, he founded Coulter Ridge Capital, another private investment firm. He is a General Partner of The Yearling Fund, a venture fund that invests in early stage companies. Bill is presently a director of a number of privately-held, early stage companies in several states, serving as Chair of several.

Bill has been involved in numerous civic and business organizations in Kentucky, including the Kentucky Opera and the Jefferson County Air Board. In Tucson, he has been involved at The Arizona Sonora Desert Museum for 15 years, holding several positions on the Board including Chair on two separate occasions. He was formerly a member of the Board of The National Zoo in Washington, D.C.

Bill has been speaking with students in our entrepreneurial finance course for 15 years and serves on the Department's Professional Advisory Council.

Congratulations to **Finance Alumnus Chris Campisano** who won the UA Alumni Bear Down Award, given to an individual who has performed meritorious service on behalf of the University of Arizona and its students.

Chris (BSBA-Finance '82 and MBA-UChicago) is a Partner and Managing Director of Investment Strategy for Risk Premium Investment Management Company. He is also a founding member of the Chicago Quantitative Alliance, or CQA — perhaps the most prestigious association in the world for quantitative investment professionals.

Although he has been based around the U.S., Chris has maintained close ties to the Eller College and the University. For 10 years, he has served on the investment committee for the student-run portfolio that manages \$1.4 million of the UA Foundation's endowment. He has been an active member of the Eller Finance Department's Professional Advisory Council for the last six years.

For the past four years, Chris has worked closely with finance honor students participating in the annual CQA Investment Challenge, in which students act as managers of a long/short equity hedge fund. Making multiple trips to Tucson each year, Chris mentors and advises the students, reviews their portfolios and provides constructive feedback. Students and Eller College faculty agree that Chris' support and guidance improves both the quality of the students' portfolios and, more importantly, their understanding of the complex issues involved in hedge fund management. And, under Chris' guidance, the 2017 Eller CQA team beat out 49 other schools to take first place in the 2017 CQA challenge! (See insert)

Financial Modeling World Championship

Qualifying for the Financial Modeling World Championship in London in December 2016, **Dr. David Brown** is now one of the top 20 financial modelers in the world. Conventional wisdom suggests firms go public to raise capital, yet many firms appear to use new capital to immediately repurchase stock. **Dr. Bonaime** and **Dr. Kahle** collected data from SEC filings to examine the consequences associated with share repurchases conducted shortly after initial public equity offerings.

2017-18 Eller Undergraduate Innovation Grant

**Dr. David Brown** will be developing a series of self-grading spreadsheets to allow students to learn Excel functions until mastery is achieved.

## **Faculty Research Update**

Prior work on corporate hedging often assumes that firms hedge using derivatives such as futures contracts. **Assistant Professor Ryan Williams** (and his coauthors Heitor Almeida and Kristine Hankins) shows that companies can also hedge by writing contracts with their suppliers and customers. The paper, recently accepted by the *Review of Financial Studies*, has important implications for the linkages between banking, financial distress, and hedging.

#### Assistant Professors David Brown and Scott

**Cederburg** (and their coauthor Michael O'Doherty) investigate optimal investments in tax-advantaged retirement accounts in a study that is forthcoming in the *Journal of Financial Economics*. Contrary to much of the conventional investment advice, David and Scott show that almost all individuals are better off diversifying their savings across both traditional and Roth accounts after accounting for uncertainty about U.S. tax rates and the progressive tax system. Assistant Professor David Brown's paper "Moral Hazard in Active Asset Management" is forthcoming in the Journal of Financial Economics. David (and his coauthor Shaun Davies) shows that as passivelymanaged investment products become less expensive, active investment managers have less incentive to generate alpha. Falling fees lead to less truly-active asset management and more "closetindexing."

**Professor Sandy Klasa's** paper "Protection of trade secrets and capital structure decisions" (co-authored with Hernan Ortiz-Molina and former UA finance doctoral students Matthew Serfling and Shweta Srinivasan) was accepted at the *Journal of Financial Economics*. Sandy and his co-authors show that when the legal protection of a firm's trade secrets is improved, firms face fewer competitive risks and increase their use of debt financing.
