SYDNEY S. WOODS ALUMNI AWARD

Carla Keegan received the Sidney S. Woods Alumni Service Award in



October 2015. This is a University of Arizona Alumni Association award to recognize an alumnus who has demonstrated unwavering interest in and loyalty to the University of Arizona. In addition, her firm commits significant resources each year to provide learning opportunities outside the classroom to our students. KLK participates in numerous career panels for accounting majors, attends all of our career fairs, and offers at least two internships for accounting students every semester and summer. Internship experiences are critical to our students' professional development and would not be possible without individuals like Carla who directs her firm to invest in our students.

These internships are especially valuable since the firm is located in Tucson and students can work part-time while attending school full-time.

On September 25, 2015, the Eller College held the first ever "Celebrate Research in the Eller College" event. The goal of the event is to honor Eller faculty and provide them the opportunity to present their research to faculty and doctoral students from across the Eller College.

In addition, this research forum provides an opportunity for Eller faculty and Ph.D. students to learn more about the research conducted by their colleagues. **Dr. Dan Dhaliwal**, Accounting Department Head, was chosen to present his ground-breaking research at the inaugural event. Dan is the perfect faculty member to initially represent the Eller College and our research

prowess and set the tone for this great research forum moving forward on an annual basis.

The Accounting faculty and Ph.D.

students from our department

initiated an annual joint research conference with the ASU Accounting department. These conferences facilitate collaboration between the two schools and provide new faculty and Ph.D. students an opportunity to present their research. Faculty Lin Cheng and Jeremy Douthit and Ph.D. students Andrew Finley and Matt Erickson presented at the first two conferences. We are excited about the possibility to increase research success through this partnership.

ACCOUNTING DEPARTMENT UPDATES



PROFESSIONAL DEVELOPMENT PROGRAMMING

Our Department continues to focus on the professional development of our students ensuring their success in the workplace following graduation. Beginning with prebusiness students, we offer an Honors Section of ACCT200 Introductory Financial Accounting. This course highlights key issues and current trends in the accounting profession to Honors students interested in learning more than the traditional curriculum. We hope this exposure will attract more top students to the accounting major. In addition, we invite the top 30% of pre-business sophomores to an **Accounting** Major Information Session to provide information to aid in their selection of an Eller major. This year, the event will be presented in a speed networking format to maximize the exposure pre-business students receive to our recent alumni. Once students have selected accounting as their major, the professional development work truly begins. The Accounting **Career Panel** for first semester juniors highlights the diversity of career possibilities with an accounting degree. The **EY Tax Seminar** exposes students to careers in tax through a case

study approach. The event is held each spring and students come away with a greater appreciation of the variety and complexity of the tax profession.

Finally, the highlight of each semester is **Meet the Firms** which brings together undergraduate and graduate students with professionals from public accounting, industry, and governmental organizations. Starting in Spring 2015, the event moved from its traditional location of the McClelland Hall Atrium to the Student Union Ballroom. The change was necessary due to the significant increase in firms interested in participating in Meet the Firms. We were able to increase attendance by 30% (from 22 to 29 firms/companies). The new venue also provides a better forum for discussion between professionals and students.


We could not offer students such wonderful events without the willingness of so many professionals to share their expertise and experience. The Department is grateful for the tireless dedication of our alumni and partners.

MASTERS OF SCIENCE IN ACCOUNTING (MSA)

The Accounting Department is continuing to grow the Master of Science in Accounting program. The program is geared towards students with flexible needs, such as international and non-traditional students. It is also intended to help students obtain their CPA license. The program started with 17 students in 2012 and currently has 46 students enrolled. We continue to receive many outstanding applicants.

MASTER OF ACCOUNTING (MACC)

College Choice ranked our program as the 29th best Masters of Accounting program for 2015. Our Master of Accounting program offers students an option between two different tracks of study: Audit or Tax. These tracks provide our students with a curriculum specifically aimed to support their post-graduate career goals. In our efforts to continue to improve the curriculum, we will offer a new course covering Accounting Ethics in Spring 2015 to help students who are trying to obtain a CPA license in a state that requires an accounting specific ethics class for certification. More information regarding the courses within each track of study can be found on our website. We continue to have outstanding placement statistics and strong student success in their post-graduate careers. (See graphs on last page.)



The MAcc and MSA programs offer numerous Teaching Assistant (TA) positions to participants in the programs; we currently have 29 students serving as TAs. Donations made to the Department help to fund TA positions, making the MAcc and MSA programs more affordable for those students. Serving as a TA is also a very enriching experience that allows students to gain a deeper understanding of the course material.

BUSINESS CAREERS AWARENESS PROGRAM

2015 represented the 11th anniversary of the Business Careers Awareness Program (BCAP). This program is a joint partnership between EY and the Department. Since inception, nearly 350 high school students have participated in BCAP. During the week, students are exposed to business concepts and the accounting profession through course work, case competitions, and field trips.

Of the BCAP participants who choose to attend UA, 60% have selected an Eller major with 33% of those students choosing accounting as their major. Last year the program truly came full circle when Ryan Appel, a 2010 BCAP participant, completed his undergraduate and graduate degrees in Accounting, served as a resident assistant for BCAP and joined EY in Fall 2015 as an audit staff member.

REMEMBERING MARK TROMBLEY



Mark Trombley, Beach Fleischman Professor of Accounting, died unexpectedly at his home on January 20, 2015. Mark

served as a member of the Eller faculty at the University of Arizona since 1990, when he completed his doctoral degree at the University of Washington. Prior to that, he worked for Deloitte from 1976 to 1986.

Mark was a selfless colleague who was very generous with his time and talents. He published over 20 articles in high quality accounting and finance journals. He also wrote a textbook on accounting for derivatives and hedging. He was active nationally through his service to the accounting research community, serving on the editorial board of The Accounting Review from 2005-2008 and then as an editor from 2008-2011. He was an ad hoc reviewer for many different accounting and finance journals and was a member of several American Accounting Association researchoriented committees, such as the Wildman Award Committee and the best dissertation award for the Financial Accounting and Reporting Section.

Mark was also an award winning teacher who won recognition from the University of Arizona and the Arizona State CPA Society. Students greatly appreciated his teaching style and highly respected his knowledge of the subject matter. In addition, accounting doctoral students benefitted greatly from Mark's time and attention. He was a committee member for over 30 doctoral students and provided research assistance and guidance over time to nearly every doctoral student in the accounting program during his tenure as a faculty member.

The Accounting Department hosted a day-long research workshop event in Mark's honor in late Spring 2015. We appreciate the many individuals and firms who contributed to the Accounting Department in Mark's honor. Funds will be used to help defray travel and research expenses for doctoral students.

HOMECOMING GOLF TOURNAMENT

Beta Alpha Psi and the Accounting Student Association continue to host a golf tournament on the Friday of Homecoming weekend. The event is open to current undergraduate and masters students as well as professionals and alumni.

ACCOUNTING STUDENT ASSOCIATION

The Accounting Student Association (ASA) is a student focused service and professional organization comprised of approximately 80-100 student members and 14 executive board members. **Phillip Blanchard** serves as faculty advisor.

ASA offers students great opportunities to network with local, national, and global firms at bi-weekly meetings. In these meetings a select group of volunteers and recruiters from potential future employers interact with members.

ASA members also actively participate in philanthropy, fund raising, and socializing events throughout the academic year. As a result of their hard work and dedication to fundraising activities, ASA is very proud of their annual commitment to "give back" to the Accounting Department.

At the Spring Banquet in April, ASA continued this proud tradition when they presented Dr. Dhaliwal a check for \$5,000. ASA has contributed a total of \$40,000 over the years.



BETA ALPHA PSI

Beta Alpha Psi had a successful year with an increase in membership to approximately 50 junior and senior accounting majors. **Leslie Eldenburg** is the faculty advisor.

The organization meets weekly. Initiatives such as a Speed Networking Event and a Local Mentorship Program have been incorporated into the organization's activities this fall with the intention of encouraging engagement and professional growth through networking opportunities. The Speed Networking Event provides opportunities for members to interact with professionals from multiple public accounting and industry firms, with 5-7 minutes dedicated to each company. This activity helps students learn the importance of first impressions and appropriate conduct in interview situations. It also benefits firms by offering an additional opportunity to introduce themselves.

The Local Mentorship Program focuses on connecting members to local accountants to encourage development of personalized professional relationships with readily accessible individuals. The aim of the program is to increase retention of accounting students in the Tucson area. Beta members continue to provide tutoring, exam reviews, and proctoring for introductory level accounting classes such as: ACCT 200, 210, and 250.

PWC CASE COMPETITION

Each year PwC and the Accounting Department faculty and students team up to participate in an annual case competition joining nearly 5,000 students from more than 100 colleges and universities nationwide. Selected teams of students are allowed two weeks to prepare a 20-minute live presentation focusing on an assigned business case scenario.

During the 2014 competition, 46 University of Arizona students were organized into 10 teams. Each team was supported by an accounting faculty member and PwC professional. Although competition was fierce, the "Mixed Generations" team was selected to move on to the next level of competition.

This is the third consecutive year our Arizona local winning team moved on to the semi-finalist round of the national competition. After reaching the finalist round in 2012 and winning the national grand prize in 2013, our 2014 team "Mixed Generations" (pictured above) just missed a trip to the finals in New York after a hectic elimination round.



Where Do Our Graduates Go?


